FBU Code of Conduct for Coaches/Players/Parents: It is of paramount importance that all members of the FBU National Championship family must demonstrate the highest standards of ethics, sportsmanship, and adhere to our core values. Those values include trustworthiness, integrity, respect, responsibility, and fairness. All players, coaches, game officials, and administers must be treated with mutual respect. Profanity or obscene gestures will not be tolerated at any time. Offensive remarks of a sexual or racial nature, trash-talking, taunting, boastful celebrations or other actions that demean individuals or the sport are not allowed. Players should demonstrate concern for others and never engage in reckless behavior that might injure themselves or cause injury to opponents. All FBU National Championship participants agree to abide by all applicable game and competition rules without exception. Our coaches are role models and must set an example -- in particular, complaining about decisions or arguing with game officials during or after the game is strictly prohibited. It is a privilege to be involved with this event. Suspension or termination of that participation privilege is at the sole discretion of All American Games. All coaches, players and parents/guardians in attendance at game sites and Stay and play hotels <u>must abide by this Code of Conduct.</u>

National Championship Governing Body: The National Championship Governing Body has <u>sole</u> authority to investigate and take appropriate disciplinary or corrective measures in <u>any</u> occurrence <u>on or off</u> the field that jeopardizes the integrity of the FBU National Championship and violates the FBU Code of Conduct for Coaches/Players and Parents. Examples include, but are not limited to, any team or player engaging in any act unbecoming or designated as unfair, outside of standard football rules or effects the competitive aspects of the games. Such acts can result in the cancelation, postponement, termination or forfeit of any game and dismissal of athletes from a game or the tournament. The Governing Body can delay, cancel, postpone or terminate any contest and dismiss any player, coach and parent from a game, hotel and the tournament if necessary. The Governing Body may deem a team or individual player or players ineligible or terminate a team administrator or coach. The National Championship Governing Body decisions are final, binding and not subject to appeal. The NC Governing Body has the authority to designate an FBU official or the Game Referee to act as the boards official representative at a game site. The designated on-site official has full authority to execute policy on behalf of the National Championship Governing Body. <u>Playing Rules & General FBU Regulations:</u> I agree to abide by all NFHS & FBU playing rules and general regulations pertaining to the playing in the FBU National Championship Tournament.

Participation: I understand that participation in the 2018 Football University National Championship ("the Event") involves certain risks, including, but not limited to, serious injury and death. I am voluntarily participating in the Event. I understand the danger involved and agree to accept all risks of my child's participation.
